

Privacy Statement

PERSONAL DATA THAT WE PROCESS

LFS BV may process personal data about you, because you use the services of LFS BV, and/or because you have provided these to LFS BV by filling in a contact form on the website. LFS BV may process the following personal data:

- Your first and last name
- Your address details
- Your telephone number
- Your email address
- Your IP address

WHY WE NEED DATA

LFS BV processes your personal data to be able to contact you by phone if you request this, and/or to contact you in writing (by email and/or by post) if you cannot be reached by phone unexpectedly. In addition, LFS BV may use your personal data in the context of executing an agreement of assignment with you, usually consisting of legal services.

HOW LONG WE STORE DATA

LFS BV does not retain your personal data for longer than is strictly necessary to achieve the purposes for which your data is collected. Your data is archived after the goals are achieved. They are not used further.

SHARING WITH OTHERS

LFS BV only provides your personal data to third parties if this is necessary for the execution of an agreement with you or to comply with a legal obligation.

WEBSITE VISIT MAPPING

On the website of LFS BV, general visitor data is kept, including the IP address of your computer and the time of retrieval and data that your browser sends. This data is used for analyses of visitor and click behavior on the website. LFS BV uses this information to improve the operation of the website. This data is anonymized as much as possible and is not provided to third parties.

GOOGLE ANALYTICS

LFS BV uses Google Analytics to keep track of how users use the website and how effective the AdWords ads of LFS BV are on Google search result pages. The information obtained in this way, including the address of your computer (IP address), is transferred to and stored by Google on servers in the United States.
